- [1] The appointment is purely temporary in nature and is offered for a period of (02) two years from the date of joining by the candidate. During the period of (02)two years, the candidate will be on probation and his/her performance will be assessed with reference to the results obtained by the students of the College concerned in the University Examinations and by such other devices as prescribed by TTWREI Society for the performance appraisal of its employees. His/Her probation will be declared to have been completed successfully, within a continuous period of three years, subject to the condition that he / she is found to be a competent Principal based on the results of the College and other

As per the Financial Code, only a regular employee can be a DDO (Drawing and Disbursing Officer).

As per the Degree College Service rules apart from other mandatory qualifications Ph.D is mandatory for the post of Degree Principal.

As per the Service Rules a regular employee cannot be made to work under / report to a retired person / part time employee.

Through the ref.2nd cited, the Secretary, TTWREIS (Gurukulam) had issued notification inviting the applications from Rtd.Jr.College Principals of TTWREIS/TSWREIS/TREIS and Govt Degree/ Aided colleges for the post of Principal on Part time/Out Sourcing basis.

The Secretary, TTWREI Society has decided to take the services of such retired employees as Incharge Principals of TTWR Degree Colleges till the regular arrangements are made.

In view of the above, the services of Smt.B.Naga Swarna, is engaged as Incharge principal of TTWRDC(G), Shadnagar on temporary basis.

The following are the terms and conditions:

1. His/Her services are engaged purely on temporary basis.
2. His/Her remuneration is Rs.40,000/- per month. They are not entitled to claim regular scales of pay or regularisation.
3. He/she shall discharge duties as per the Society norms.
4. The society shall withdraw the services of the Incharge Principals without any prior notice if their services are not required/ satisfactory/ upto the mark.
5. He/She has to submit guarantee bond for Rs.5.00 lakhs in the prescribed format on non-judicial stamp paper of Rs.100/- (copy enclosed).

Smt.B.Naga Swarna, is directed to report before the **Regional Coordinator, Ranga Reddy District** for further instructions.

The Incharge Principals of TTWR Degree College have to perform the duties as assigned to the Principals of Residential institutions run by the TTWREI Society.

The Incharge Principal who was already authorised to open the Bank account(Savings Account) in the name of the "Principal, TTWRDC(G), Shadnagar" in the nearest Nationalized bank (SBI) with nearby RJC/RS Principal as joint check power for maintenance of funds and to procure various infrastructure items authorized by TTWREI Society.
